- 4. Submit a copy of your California Seller's Permit and Food Handlers (ServSafe) Certificate.
- 5. Include proof of liability insurance.
- 6. Make sure you sign the application where indicated.
- 7. If a contract is issued, management will determine the location of your booth. Locations are subject to change year to year.

### 2016 Julian Apple Days Festival Food Space Application

All food and beverage vendors selling, providing samples or giveaways must have a Temporary Food Facility (TFF) Permit issued by San Diego County Department of Environmental Health. The cost of the TFF Permit is the responsibility of the vendor and the permit cost is not in any way associated with the cost of the event vendor space rent. A copy of the TFF Permit should be submitted to the Chamber of Commerce along with your vendor space application to ensure availability at the event. The County of San Diego issues the TFF Permit at a cost of \$135.00 for a 1 to 4 day event. The TFF Permit process is solely between the vendor and the San Diego County Department of Environmental Health. The TFF Permit must be submitted and approved 14 days prior to the event or the San Diego County Department of Environmental Health will impose an additional \$70.00 late fee. Food handlers certificates and other requirements imposed by the Department of Environmental Health are the responsibility of the vendor and not the Julian Merchants Association.
