Midnight April 4, 2020 effective the following must wear a facemask (cotton).

- Stores
- Pharmacies
- Gas stations
- Those working with public not required for office workers not dealing w/public.
- This could be expanded in the future.

Additional implementations for our county:

- All businesses that remain open must prepare and post a sanitation and social distancing protocol in a visible location to the general public. This will be due on April 7, 2020. You will be able to download from county.
- All parking lots will be closed for beaches and parks they want you to go to places you can walk to for outdoor activities.

Some numbers

- SD County 966 positive cases which includes 16 deaths
- Our District 58 cases 6% of total
- Want to dispel the myth that it is more deadly to the elderly
- Individuals have a responsibility to adhere to guideline
- SD has the highest number of test kits in the state.

Malaria Drug for COVID

How long will this go on?

Depends on the actions of the public with keeping and following orders – Flatten the curve. Projections are out farther until a vaccination is available. Vaccination not possible for probably another year.

The antiviral meds are moving faster.

Why no N95 Masks for public

It is reserved for the Health Care Professional while dealing with COVID-19 cases.
